- CRAA Board Meeting: June 25, 2025
- Interviews: Starting June 2025
- First Scope of Work Starts: Q4 2025 (Framing) 2027-2028 (Finishes)

Prequalification

Documents to Accompany Prequalification

- The following documents must be received from all bidders
 - ✓ Bond Letter from Surety
 - ✓ Declaration of Affirmative Action Proposed DBP Plan
 - ✓ CMH Prequalification Questionnaire
 - ✓ NDA
 - ✓ SSI
 - ✓ Past Projects – Three Projects
- Required for submittal of bid – 1st Tier

Process of Bidding

Pre-Qualification Package

Notice of Pre-Qualification

Receive Solicitation from Building Connected:

- Include Bid Package of Scope
- After Submission, Review Internally
- Commence with Scope Interviews
- Award Recommendation

Award to Best Value as per CRAA contract

Documents to Accompany Bids

- ✓ DBP Affidavit Intent to Perform
- ✓ Subcontractor Insurance Limits and Coverage

Subcontractor Default Insurance (SDI) Program

SDI Program – Post Award

- ✓ All contractors are required to submit as a condition of letter of intent.
- ✓ Contracts over \$100,000
- ✓ Compass – Qualification for SDI approval
- ✓ Payment and Performance Bond in lieu of SDI – at CMRs discretion.

Contract Terms

✓ **Prompt Payment**

- ✓ Hensel Phelps Subcontract terms agree to payment to the Trade Partners within 7 days of receiving payment ourselves.
- ✓ Typical payment duration from CRAA to Hensel Phelps right now is 24 days.

✓ **Liquidated Damages**

- ✓ Liquidated Damages are \$40,000/day for the terminal building (January 29, 2029) and \$15,000/day for the Public Safety Building (Date TBD).
- ✓ Damages are a flow down from damages that may or may not be assessed by CRAA.

✓ **Retainage**

- ✓ Retainage follows Ohio Statute: 8% is held on labor only until 50% of the work is complete, at which point no further retainage is held. Retainage is released upon completion of the work. (Assuming the schedule of values is 50/50 labor/material and it is billed in the same ratio, a total of 4% over the life of the contract would be held).

Large Business DBP Participation Plan

Participation Calculations are based on 49 CFR Part 26

- Self Performed Work = **100%**
- Trucking = **100%** (Owned and operated by DBPs)
- Material Providers & Equipment Rentals = **60%**
